### WHY DO THEY CALL IT THE "YELLOW BOOK"?

The Yellow Book goes by many names:

- Government Auditing Standards,
- Generally Accepted Government Audit Standards,
- GAGAS (I love that one... pronounced "gag us"), and, of course,
- The Yellow Book.

If you are a CPA, you can earn free CPE credit by testing the self-study course, "The Yellow Book Interpreted" Qualifications and deadlines apply.

Until very recently, to get the standard, you had to purchase an actual little Yellow Book from the government. Now the standards and all of the

related updates are available on the GAO's website at www.gao.gov. As of this writing, the 2011 Internet Version of GAGAS is online. The reason they have only an internet version is that the AICPA (American Institute of

Certified Public Accountants) is going through a significant rewrite of their auditing standards, which they call "the clarification project." The GAO will finalize their version once they are certain that the AICPA standards turn out as they expect.

### Why does the Yellow Book exist?

The GAO is the legislative auditor for the federal

government. The GAO changed their name from the General Accounting Office to the Government Accountability Office. They first published the Yellow Book back in the 1970s as a guide for their own auditors. At some point, they decided to share their guide with the public.

In 1984, Congress passed a law called the Single Audit Act. The Single Audit Act is what made the Yellow Book a bestseller! The purpose of the law was to reduce the number of audits that recipients of federal grants had to tolerate. Before the Single Audit Act, it was common for several parties – the grantor (the feds), the state agency responsible for administering the grant, and the sub-recipient of the grant – to audit a particular grant. Once I was the accountant for two new federal grants. I was audited by the federal grantor, the state auditor, and the internal auditor – all within the span of a month!

But with passage of the Single Audit Act, the Yellow Book became a more significant standard for a larger group of auditors. The Single Audit Act (interpreted by the OMB in OMB Circular A-133) states that the audit should be conducted in accordance with all the requirements contained in the Act and also follow Government Auditing Standards. Specifically, OMB Circular A-133 says, "...audits will be conducted in accordance with generally accepted government auditing standards." And, as we know, generally accepted government auditing standards is nicknamed the Yellow Book.

# The Yellow Book has to be called into play by someone else

Just because the Yellow Book exists does not mean you have to follow it in conducting a governmental audit. The Yellow Book has to be called forth by something or someone external to it. The GAO doesn't say it exactly the way I did.
