

## Research Article

### From "Board Pursues Unauthorized Practice to Protect Public and the Profession," November 2009 Texas State Board Report

Although not all AGA members are CPAs, many deal with the public in their daily jobs or in their side jobs, and some may consider public practice in the future. Most will be surprised by what they don't know about the unauthorized practice of public accountancy (UPPA) and how it applies to them.

Over 25 years ago, Texas A&M University researchers surveyed Texas residents to examine the public's perception of the use of the term accounting. The survey revealed that, by a margin of 61% to 19%, the public perceived that a person offering accounting services to the public was a licensed CPA. The continued existence of this misconception was most recently verified in 2006 when a polling firm employed by the Texas State Board of Public Accountancy (the "Board") surveyed Texans again. By overwhelming margins, all tested permutations of accounting and auditing services were believed to require licensure. These findings held true across regional, gender, racial, age, income, and educational demographic lines, even among those in the financial services sector.

#### Establishing Restricted Terms

In addition to the use of the Certified Public Accountant, or CPA, designation, Texas law restricts the use of the terms "accountant" and "audit" and their derivatives while offering services to the public, to the exclusive use of Texas CPAs operating through CPA firms licensed by the Texas State Board of Public Accountancy. Restricting the use of these terms serves to protect the public from non-licensees asserting an expertise in accounting they do not have. As demonstrated by the public surveys, these terms are closely associated in the public mind with the practice of public accounting, and a common assumption is that any individual or business offering to perform such services is licensed by the Board.

#### Unauthorized Use of Restricted Terms

The most common UPPA violation is the use of the terms "accountant" and "accounting" by unlicensed entities offering services to the public, a practice prohibited by the Public Accountancy Act. Other violations include use of derivations of the term "audit" to refer to services other than attest services, misuse of the CPA designation, and the performance or offer to perform attest services, which include audits, reviews, and compilations.

One source of confusion regarding the legality of these terms is their use by unlicensed agencies or businesses to refer to internal departments as "accounting departments" or to staff members within these departments as "accountants." Neither violates the Public Accountancy Act as long as these organizations' services are not offered to the public.

#### Violations by CPAs

Keep in mind that UPPA investigations may be opened on licensees. CPA firms using restricted terms for unlicensed employees can elicit investigations. Files may also be opened on CPAs using restricted terms in association with unlicensed firms, using the CPA designation in association with unlicensed firms without the proper disclaimer, or providing compilations (including issuing financial statements) through unlicensed firms.

#### Enforcement

Identifying the unauthorized practice of public accountancy by licensees and non-licensees is a function of the Enforcement Division of the Texas State Board of Public Accountancy, specifically the UPPA Division. This division takes action against unlicensed persons in a manner that is intended to be informative rather than punitive in order to protect the public from being misled. Employees search for violations by unlicensed entities and investigate complaints from CPAs, community members, other state agencies, and members of the Constructive Enforcement Advisory Committee (CEAC). Complaints sent to the Board that may result in a UPPA file may include anything from business cards, websites, newspaper advertisements, fliers, pictures of signs, emails, or any other evidence of alleged violations of the Act or Board rules.

Keep in mind that a file cannot be opened without evidence of a violation and reason to believe that the subject of the complaint generated or contributed to the violation. Please be aware that if you provide your name or information with your complaint, the Board may be required by under the Public Information Act to provide that information to the subject of the complaint if requested.
