	Dr. Carolyn Conn and Members of the St. Edward's University finalist team, in the AGA Graduate Finance Case Challenge (placing in the top three), including Leigh Anne Floyd, Sandra Hernandez, Cynthia Wainwright-Branigan, and Maura Valle ; discussed their experience regarding their project, a Citizen- Centric Report for the City of San Diego, by demonstrating an innovative and creative means of communicating the City of San Diego's financial information to its

citizenry using the Citizen-Centric Report format.
<i>November 2012</i> : Evelyn Brown , CGFM-Retired, AGA 2012-2013 National President, presented on the topic "Our Professional Journey" and shared her insight on how to acquire adequate skill sets for career development; plotting goals and objectives at different levels in a career path; and the importance of being flexible in your career path.
